

ORDINANCE NO. 249

AN ORDINANCE ENACTED PURSUANT TO THE TINICUM TOWNSHIP CABLE TELEVISION FRANCHISE ORDINANCE GRANTING A CABLE TELEVISION SYSTEM FRANCHISE RENEWAL TO COMCAST OF SOUTHEAST PENNSYLVANIA, LLC.

WHEREAS, Tincum Township ("Township"), pursuant to Ordinance No. 83 enacted October 2, 1990 with an effective date of January 1, 1990, (hereinafter referred to as "Ordinance") is authorized to grant one or more non-exclusive franchises to construct, maintain, own, extend and operate a cable television and cable communications system within the Township; and

WHEREAS, Tincum Township, pursuant to Ordinance No. 84, enacted October 2, 1990, granted unto Comcast of Southeast Pennsylvania, LLC. ("Comcast"), its successors and assigns, a non-exclusive Franchise pursuant to Section 3 of Ordinance 83, which Franchise has been extended from time to time; and

WHEREAS, Township is desirous of further extending the Franchise; and

WHEREAS, Township has also considered and analyzed the plans of Comcast for the continued operation of a cable television and cable communications system and found Comcast's technical ability, financial condition and character to be adequate and feasible in view of the needs and requirements of the Township; and

WHEREAS, Township has determined that it is in the best interest of, and consistent with, the health, safety and welfare of the citizens of Tincum Township to grant a non-exclusive Franchise to Comcast to operate a cable television and cable communications system within the confines of the Township and on the terms and conditions set forth.


NOW, THEREFORE, Township hereby awards Comcast and Comcast hereby accepts the terms of the negotiated non-exclusive Cable Franchise Agreement (hereinafter referred to as the "Agreement"), between Tincum Township, a Township of the Second Class, with its principal offices located at 163 Municipal Road, Pipersville, PA 18947 and Comcast Cable T.V., Inc., its successors and assigns, for the occupation and/or use of the public way within Tincum Township, for the construction, operation and maintenance of a cable television and cable communications system, according to the terms set forth in the Agreement which is attached hereto as Exhibit "A" and incorporated herein by reference, which shall remain in effect for fifteen (15) years from the date of execution of said Agreement, or from the effective date of this Ordinance as determined by the Board.

Ordinances 83 and 194 are hereby repealed effective upon the effective date of the Franchise awarded herein.

This Ordinance shall become effective five (5) days after enactment.




